



Doctor of Medicine Program (MD) | Continuing Students Eligible for the Interim Exception

The Cost of Attendance (COA) includes direct charges billed by SMUSOM and estimated indirect expenses for the applicable enrollment period. It is used for financial aid purposes and does not reflect the amount a student will owe the University. This COA is based on SMUSOM's tuition and fee structure and the standard full-time curriculum for the applicable phase of the MD program. Students enrolled outside the standard full-time curriculum may have their COA adjusted based on actual enrollment, assessed tuition and fees, program phase, and applicable federal student-aid eligibility rules. Actual expenses may vary.

What is included in the COA?

The COA is made up of two types of costs: direct and indirect.

- **Direct costs** are charges billed directly by SMUSOM. These include tuition, administrative fees, and applicable Cayman entry/student visa fees. During Clinical Medicine, direct costs also include malpractice insurance and the applicable graduation fee.

- **Indirect costs** are estimated expenses a student may incur while enrolled that are not billed directly by SMUSOM. These include books and supplies, food and housing, utilities, phone and internet, transportation, USMLE exam fees, personal expenses, and applicable Federal Direct Loan fees.

*Federal Direct Loan Fees: Estimated origination fees charged by the U.S. Department of Education for eligible federal student loans. For continuing students eligible for the interim exception, the allowance may include estimated Direct Unsubsidized Loan and Direct PLUS Loan fees, if the student remains eligible. Actual fees may vary based on eligibility, loan type, borrowing amount, loan period, enrollment status, annual/aggregate limits, and other financial assistance. Loan fees and indirect costs are reviewed annually.

Important Notice: Cost of Attendance amounts are estimates used for financial aid purposes and are based on full-time enrollment for the applicable phase of the MD program. The COA may exceed the amount a student is eligible to borrow through federal student loans. Students enrolled less than full-time may have their COA adjusted based on actual enrollment, assessed charges, program phase, and applicable federal student-aid eligibility rules.

Notes:

- Food and Housing includes the standard housing and food allowance for the applicable phase of the program.
- USMLE exam-fee allowances are estimated indirect costs included in Basic Science Term 5 and Clinical Medicine Term 8.
- Cayman entry/student visa fees are direct charges included in Basic Science Term 1.
- Malpractice insurance is a direct charge included in Clinical Medicine Terms 6-10. The graduation fee is a direct charge included in Clinical Medicine Term 10.
- Federal Direct Loan Eligibility Notice: This COA is intended for continuing students who qualify for the federal interim exception, also known as the legacy borrower exception. Eligibility is subject to applicable annual, aggregate, and lifetime limits, enrollment status, satisfactory academic progress, and other Title IV eligibility requirements. The COA may exceed a student's federal loan eligibility, and students are responsible for costs not covered by federal student loans, scholarships, private financing, institutional payment arrangements, or other resources.
- Federal Direct Loan Fees are estimated origination fees charged by the U.S. Department of Education for eligible federal student loans. For legacy borrowers eligible for the interim exception, the allowance may include estimated origination fees for Direct Unsubsidized Loans and Direct PLUS Loans, if applicable. Actual fees may vary based on eligibility, loan type, borrowing amount, loan period, enrollment status, annual/aggregate/lifetime limits, and other financial assistance.
